NYC LANDMARKS50 ALLIANCE TO CELEBRATE 50TH ANNIVERSARY OF THE LANDMARKS LAW

NEW YORK CITY – April 2015 marks the 50th anniversary of the passage of New York's nationally-acclaimed Landmarks Law – the foundation of historic preservation in New York City, and the model for similar efforts throughout the United States. Central Park, Coney Island's Wonder Wheel, Radio City Music Hall, Grand Central Station, Jackson Heights, and the Ladies' Mile Historic District are just some of the well-known and beloved places that have been preserved because of this important NYC legislation.

"New York City, for all its bustle and vigor, is also a cherished place for residents and tourists alike. This city is the jewel in the crown of our rich national, cultural legacy that we must honor and protect," said Barbaralee Diamonstein-Spielvogel, Founder/Chair of the NYC Landmarks50 Alliance. "There is hardly a neighborhood, a New Yorker, or a visitor, who has not benefited from New York City's grassroots preservation movement, which reflects the vast diversity of our city. Landmark designation protects our historically significant neighborhoods throughout the five boroughs, as well as the celebrated landmarks of New York City. This legislation has enhanced the quality of life for all of us – at home, at work, and at play – and ensures that our shared architectural legacy continues to be maintained and celebrated throughout the world."

On April 19, 1965, Mayor Robert F. Wagner signed the Landmarks Law of NYC, initiating the historic preservation era and creating the Landmarks Preservation Commission. The agency is responsible for protecting almost 1,400 individual landmarks, 117 interior landmarks, 10 scenic landmarks, 112 historic districts, and 20 historic district extensions located throughout all five boroughs.

To commemorate the 50th anniversary, NYC Landmarks50 has planned the following events to develop new audiences and inspire future preservationists:

"Honor Our Past, Imagine Our Future"
